RULES OF COMPETITION

Organizer: Cesis Music Secondary School named after Alfreds Kalnins together with support fellowship of Cesis Music Secondary School named after Alfreds Kalnins

Venue: Cesis Music Secondary School named after Alfreds Kalnins

Time: at 11:00 a.m. December 4, 2020
Registration of participants starts from 8:00 a.m.

Aims:

- Develop students' professional skills and the culture of performance.
- Insure singers the possibility to demonstrate their skills and talents.
- Promote young people's interest in jazz and popular music.
- Stimulate the exchange of experience and cooperation between students, teachers other interested parties (producers, composers, patrons etc.)

Participants and programme:

- The competition participants can be Music School and vocational Music Secondary school students.
- Solo singers aged 12 – 15 Group I
- Solo singers aged 16 – 20 Group II
- Duets and trios 12 – 20 Group III
- The participants are to perform two Latvian or foreign different style and character jazz or popular music hits (songs that are widely known), appropriate to the singers' age and capabilities.
- Both songs are to be performed by heart.
- The participants are to wear concert clothes and shoes.

- The performance can be accompanied by small accompanying group – piano, guitar or other musical instruments (the organizers must be notified about the participants' needs in due time to ensure the supply of technical equipment).
- Accompaniment cannot be played in phonograms or programmed in synthesizers, except for individual elements, if required by the music style.
- Phonogram tracks are allowed only for Group I vocalists, who are attending Music schools. Phonogram needs to be submitted in WAV format. MP3 format is also allowed, only with a bitrate of 256 kbps or more. Phonogram track needs to be submitted together with online application form. Phonogram track needs to be sent to an e-mail: inga.kreile@gmail.com
- After the application submission, the program of performance cannot be changed.
- Duration of the performance must not exceed 8 minutes.

Evaluation:

- Professional jury evaluates the performances in a 10-point system, maximum amount of points for both songs is 100.
- The composition of the jury is approved by the headmaster of the Cesis Music Secondary School named after Alfreds Kalnins.
- The members of the jury do not evaluate their own students.
- The decisions of jury are final and undeniable.
- The jury may grant the Grand Prix to the participants who have shown an excellent performance.
